



Competency Guidelines for Culturally Responsive Relationship Focused Practice Promoting Early Childhood Mental Health (ECMH-E®)

Early Childhood Mental Health Mentor Clinical (ECMHM-C) Endorsment® Requirements

<p>Education</p>	<p>Masters or Doctorate, including Master of Arts (MA), Master of Science (MS), Master of Education (MEd), Doctorate in Education (EdD), Master of Social Work (MSW), Master of Nursing (MSN), Doctor of Psychology (PsyD) Doctor of Philosophy (PhD), Doctor of Osteopathy (DO), Medical Degree (MD), or other degree specific to one's professional focus in infant mental health, postgraduate specialization, or university certificate program</p> <p><i>If applicants would like to use educational experiences to demonstrate competencies they may upload unofficial transcripts from any coursework or degrees earned</i></p>
<p>Training</p>	<p>A minimum of 48 clock hours of training, including:</p> <ul style="list-style-type: none"> ➤ 30 hours of Competency based training ➤ 15 hours about the provision of reflective supervision/consultation ➤ 3 hours related to diversity, equity, inclusion, and access (DEIA) in ECMH <p>Applicants will include as many hours of relationship-based training and/or continuing education as necessary to document that competencies (as specified in Competency Guidelines®) have been met. <i>ECMHM-C applicants submit an average of 90 hours</i></p> <p>For those whose degree is in a field that is unrelated to ECMH, more specialized in-service training may be required to meet the breadth and depth of the competencies</p>
<p>Work Experience</p>	<p>Meets work experience for Early Childhood Mental Health Specialist, which is two years, postgraduate, supervised work experience providing culturally sensitive, relationship-focused, early childhood mental health services. This specialized work experience must:</p> <ul style="list-style-type: none"> ➤ Be with both the young child (ages 3-6) and their biological, foster, or adoptive parent on behalf of the parent-child relationship ➤ Include relationship assessment, and parent-young child relationship-based therapies and practices ➤ These therapies and practices are intended to explicitly address issues related to attachment, separation, trauma, and unresolved losses as they affect the development, behavior, and care of the young child <p>Plus, three years of postgraduate experience providing reflective supervision/consultation (RSC) and other leadership activities at the agency, community, state or national level.</p>
<p>Reflective Supervision/Consultation (RSC)</p>	<p>Minimum 50 clock hours reflective supervision or consultation, individually or in a group. With 25 of these hours exploring the RSC the applicant is providing to others.¹</p> <p>An applicants' provider of RSC must have earned IMH-E® or ECMH-E® at ECMHM-Clinical or IMHM-Clinical or be "vetted" by NCIMHA.¹</p>
<p>Leadership</p>	<p>Applicants will demonstrate 12 months of leadership experience at an agency, community, state, or national level specific to work with or on behalf young children or their caregivers.</p>

¹ "Vetted" professionals are those interviewed by NCIMHA for their familiarity with the Competency Guidelines® and/or their experience providing RSC. NCIMHA will continue to use vetted professionals as we grow our number of Endorsed professionals, NCIMHA will end their use of "vetted" professionals on or before December 31, 2027.

Code of Ethics and Endorsement® Agreement	Signed
Demonstration of Competencies	Application will document that requirements and competencies have been adequately met through specialized education, in-service training, work and reflective supervision/consultation experience. Successful completion of the written examination, which includes a multiple choice and essay portion.
Professional Membership	Membership to the North Carolina Infant and Early Childhood Mental Health Association (NCIMHA) is required

EARLY CHILDHOOD MENTAL HEALTH MENTOR- CLINICAL CONTINUING ENDORSEMENT® REQUIREMENTS

Education & Training	Minimum of 15 clock hours per year of relationship-based education and training, pertaining to the promotion of social-emotional development and the principles and practice of infant mental health. <i>Beginning in 2024, one of these hours will be required to cover diversity, equity, inclusion, and access (DEIA) in Infant or Early Childhood Mental Health</i>
Reflective Supervision/Consultation (RSC)	Minimum 12 clock hours of RSC, individually or in a group.
Code of Ethics and Endorsement® Agreement	Signed
Professional Membership	Membership to the North Carolina Infant and Early Childhood Mental Health Association (NCIMHA) is required
